

- (1) The proposed school shall not admit students presently studying in Bhartiya Vidya Bhavan Hazira, Surat which is registered with Gujarat Secondary Education Board.
- (2) Admissions to the proposed school shall in no way affect directly or indirectly Bhartiya Vidya Bhavan Hazira, Surat school which is registered with the Gujarat Secondary Education Board. Due to the establishment of the proposed school if the ^{present} Bhartiya Vidya Bhavan, Higher Secondary School (which is a grant in aid school of the State Government) will be closed then the entire Administrative and financial liability or any other liability shall be that of the trust and the Government of Gujarat will not any way be liable.
- (3) The benefits given to the employees of Bhartiya Vidya Bhavan Higher Secondary School (which is a grant in aid school of State Government) will not be made available by the State Government to the employees of proposed school or in other words State Government shall not bear any liability in respect of the proposed school.
- (4) The proposed school shall not use the premises, including staff, play ground or any movable or immovable property of Bhartiya Vidya Bhavan. The school should be run independently in separate premises and under new staff and management.
- (5) The State Government will not bear any financial or administrative responsibility of the proposed school.
