




This is to certify that we have inspected the aforesaid building and checked all structural drawings and also inspected the existing construction at the site and have verified details pertains to the existing structure.



(School name changed from Essar International school to AMNS International School)

Dr Y D Patil (Associate Professor) & his team from Department of Civil Engineering visited to Essar International School, AMNS Township, Hazira, Surat – 394270 on dated 30/09/2022. The purpose of the visit is to be review the condition assessment and stability of the building. During site visit survey visual inspections were carried out and non-destructive test (by rebound hammer) conducted on the vertical load carrying elements (Columns). The building consists of RCC structure having Ground Plus one stories. The building was constructed approximately 27 years before as per the information given by the concern school authority.

It is found that the condition of the concern school building structure is safe and stable for its intended use subjected to following conditions.

- The undersigned SVNIT Team will not be responsible for any alteration in design, Extra construction on existing structure and changes in structural elements of the building.
- The present condition of the structure does not include any extreme man-made and natural calamities like severe flood, Earthquake & hurricane).
